PLEASE NOTE: Except for the above listed foods and drinks - ALL OTHER Beverages (soda/water/beer/alcohol, etc.) will be distributed by the management/charity for this event.

KIDS SPECIALTY RECREATION SITE VENDOR OPPORTUNITY:

No cash will be accepted at these sites – Sand Bucks will be the method of exchange for all vendors in this area.

Trailer-parking fee: \$100 for 4 days, \$200 for 11 days

There will be a charge of \$30 PER TOW for all wheeled vehicles which must be towed onto and off of the sand – total the # of tows you will require. TOW passes will be issued with your confirmation, be certain you have enough for each tow.

A 10' x 10' tent can be provided to you for an additional \$35 per day (minimum 4 days)

6' Table rental - \$20 each _____ (indicate quantity)

Chair rental - \$8 _____ (indicate quantity)

Power can be added to your space for \$100. If needed check here.

Your logo on 4' x 6' banner on event fencing \$500

Non-Consumable category (except jewelry) may have an 11-DAY exclusive for \$5,000.00 that will include a 30' x 10' space.

VENDOR'S AMENITIES:

- On site 'stack' parking at the Holiday Inn (at the tennis courts)
- Golf Cart Services on and off the beach at no additional charge
- Daily Vendor Concierge Service
- Assigned load in /load off schedule
- On Stage Entertainment Venue throughout the event on site
- Each booth space is 10' x 12'
- The World Championship of Sand Sculpting and all venues, i.e. Kids Area, Stage Area, Vendor Village and Sculpting Sites will be fenced and there will be a \$5 charge per day for all attendees.
- Most vendors will circle the inside perimeter of the fenced area for optimum exposure for each and every vendor – there will be no unsatisfactory or non-traffic vendor spaces.

EXHIBITOR SPACE:

Vendor space is 10' x 12'. All vendor gear must fit into this space, if you need additional space contact Bonnie for a 2nd space fee schedule. Please do not exhibit outside of your allotted space.

PLEASE INITIAL EACH LINE ITEM.

_____ You must provide your own booth, tent, chairs, tables, etc. and the vendor will manage your own set-up and breakdown of your area. If you need to rent items such as tents, tables, chairs, generators, etc. Please fill out the order on page 1 with the appropriate **quantities**.

_____ It is your responsibility to provide garbage containers at your booth. Any garbage must be placed in trash bags, securely tied and placed outside of your booth at the end of each day for collection.

_____ Running water is not available at your site, but ice will be available for sale.

_____ Any vendor that needs to be towed on or off the beach will be charged an additional \$30 per tow.

_____ All Vendors must supply a fully charged and date tagged ABC Fire Extinguisher at each booth. If you are cooking with any type of oil; you will be required to have a Class K fire extinguisher. The Fire inspector will be checking periodically. Please have your extinguisher present at all times.

_____ No vehicles of any kind including golf carts, cars or vans are allowed on the beach for any reason without a proper Town of Fort Myers Beach Permit and written permission from Big C Events.

_____ All merchandise and food (size, material, selling price, etc.) sold or distributed at the event are subject to approval by the event Committee.

_____ Booth assignments will be at the discretion of the event Committee.

_____ Vendors are responsible for paying all fees, and obtaining all permits required by any and all federal, state and/or local government entity. The World Championship of Sand Sculpting is not responsible for collection or submission of any such government fees or filings. Please visit www.fortmyersbeachfl.gov for local business tax information.

_____ There will be a \$50.00 charge if the event needs to clean up your vendor area after the event.

_____ Distribution, layout or hanging of any items outside of the designated booth area is not permitted.

_____ Deadline for completed application, all fees and applicable permits is November 1, 2011 or sooner if the event is sold out.

_____ Designated arrival and set up time will be determined and sent to you based on your plan choice for the event.

_____ Booths must be staffed at all time during the event hours. Night security will be provided but the event Organizing Committee will not be responsible for any issues that may occur at a booth during the event.

_____ Merchandise and food vendors will be provided with one parking pass for one vehicle at the Holiday Inn and will be valid for the duration of your plan.

_____ Parking passes will be issued in your name upon arrival/set up time at the event

_____ No merchandise using the event's names or logos may be sold at the event without signed contract from the event Committee, otherwise said merchandise is subject to forfeiture.

INDEMNIFICATION. VENDOR shall indemnify, defend, release, and hold harmless Pinchers Beach Bar & Grill, the Holiday Inn Fort Myers, SandLubbers, Big C Events, The World Championship of Sand Sculpting Organizing Committee, Fort Myers Beach Kiwanis Club, the Northside Naples Kiwanis Club, other event VENDORS, and any affiliates, officers, directors, employees, or agents thereof from and against any and all liabilities, damages, injuries, claims, suits, judgments, causes of action, and expenses (including reasonable attorneys' fees, court costs and out-of-pocket expenses) suffered or incurred as a result of any breach of any obligation of VENDOR in performance of this Agreement or VENDOR's use of the benefits. This provision shall survive the expiration or termination of this Agreement. The World Championship of Sand Sculpting shall indemnify, defend and hold harmless VENDOR, and any affiliates, officers, directors, employees, or agents thereof from and against any and all liabilities, damages, injuries, claims, suits, judgments, causes of action, and expenses (including reasonable attorneys' fees, court costs and out-of-pocket expenses) suffered or incurred as a result of any breach of any obligation of The World Championship of Sand Sculpting in performance of this Agreement or The World Championship of Sand Sculpting use of the benefits. This provision shall survive the expiration or termination of this Agreement.

TERMINATION. In the event of any attempted termination by VENDOR, The World Championship of Sand Sculpting shall be entitled to retain all payments received hereunder and shall have the right to pursue all available remedies at law or otherwise.

INSURANCE FOOD VENDORS. Vendor shall secure and maintain at least the following insurance coverage in full force and effect throughout the Term of this Agreement from an insurance carrier having an AM Best rating of A- or better: Commercial General Liability with limits of at least \$1,000,000 each occurrence and \$2,000,000 general aggregate. VENDOR shall provide certificates of insurance listing Pinchers Beach Bar & Grill, the Holiday Inn Fort Myers, SandLubbers, Big C Events, the event Organizing Committee, Fort Myers Beach Kiwanis Club, and the Northside Naples Kiwanis Club as additional insureds upon request.

INSURANCE MERCHANDISE VENDORS. Merchandise vendors are responsible for their own liability insurance and HOLD HARMLESS Pinchers Beach Bar & Grill, the Holiday Inn Fort Myers, SandLubbers, Big C Events, the event Organizing Committee, Fort Myers Beach Kiwanis Club, Bonnie Roberts Events and the Northside Naples Kiwanis Club as additional insureds upon request.

LIMITED LIABILITY. THE WORLD CHAMPIONSHIP OF SAND SCULPTING SHALL NOT BE LIABLE TO VENDOR FOR INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL OR EXEMPLARY DAMAGES, AND THE EVENT'S LIABILITY ARISING UNDER THIS AGREEMENT WILL BE LIMITED TO DIRECT, OBJECTIVELY MEASURABLE DAMAGES. EXCEPT TO THE EXTENT WHERE THIS PROVISION IS PROHIBITED BY LAW, AND EXCEPT WITH RESPECT TO THE INDEMNIFICATION PROVISION HEREIN, IN NO WAY SHALL THE EVENT'S MAXIMUM, AGGREGATE, CUMULATIVE LIABILITY TO VENDOR ARISING OUT OF OR RELATING TO THIS AGREEMENT EXCEED THE CASH AMOUNT PAID OR PAYABLE BY VENDOR TO THE WORLD CHAMPIONSHIP OF SAND SCULPTING DURING THE TERM.
